### **DISCUSSION TOPICS**

- Review of Action Item progress since the 4 December Board Meeting
  - Broadmoor/Waverly lot maintenance JEN
    - Jen spoke with Arwel Bermudo, Code Compliance Officer City of Palm Springs. Last spoke with him about a year ago. She reviewed the issues, confirmed that the lot is looking worse than ever
    - Arwel confirmed that the city has found the owners and has notified them they are in default. It is now with the city attorney. This is not a high priority for the city.
    - Next steps will be to obtain a warrant for the city <u>to</u> come clean-up the lot and send a bill to the owners.
    - Arwel reiterated for us to leave the lot as is. Do not try to clean it up.
    - Jen will summarize this issue at the annual TCGNO meeting.
  - 2020 Modernism Home Tour
    - We currently have 5 homes committed to participate in the 2020 tour; still open to adding more participants
    - We will be looking at the ticket cost for the tour; 2016 tour tickets were \$55. We discussed they should be \$75-80. Modernism Week will review as well and determine the final price.
